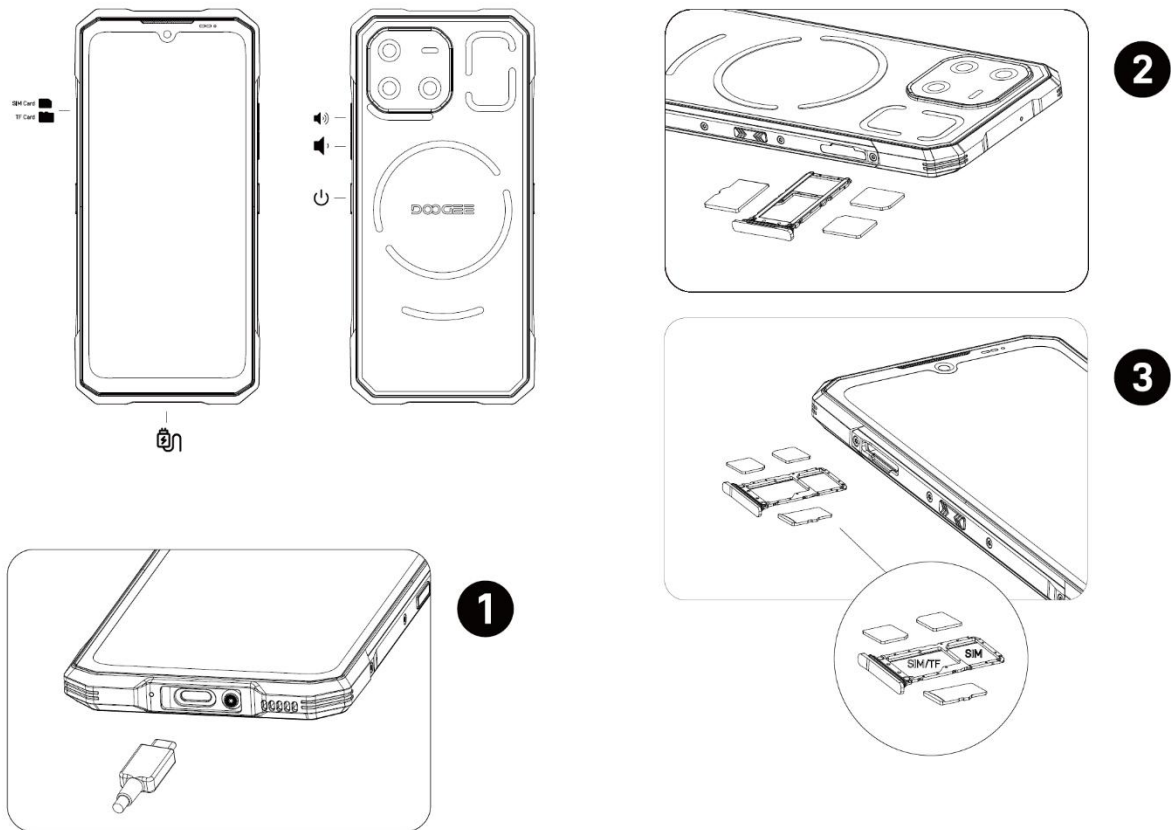
Nano-SIM

## How to insert the card



In order to make a call the Blade GT requires a SIM card be inserted.

- Use your fingernail to pull out the Card tray.
- Place the Nano card(s) and/or Memory card into the card tray. Make sure to align the card(s) based on the beveled angle and placed in the correct slot.
- Insert the card tray back into the device.

## **This device has a non-removable battery**

### How to boot

Press the power key  for 3-5 seconds to boot



To prevent possible hearing damage. Do not listen at high volume levels for long periods.

Note: The FM radio requires an analogue USB-C headset to be connected, which the device will utilise as an aerial to from which to receive the FM radio signals.

During SAR testing, this device was set to transmit at its highest certified power level in all tested frequency bands and placed in positions that simulate RF exposure during use against the head no separation and near the body with a separation of 5 mm.

SAR compliance for body operation is based on a separation distance of 5 mm between the unit and the human body. This device should be carried at least 5 mm away from the body to ensure RF exposure is compliant or lower than the reported level. 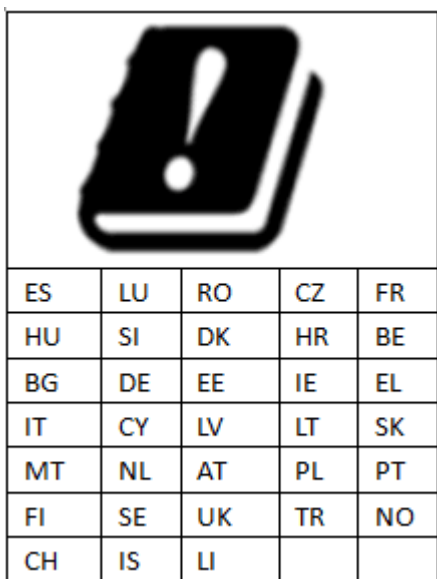

### Specific Absorption Rate (SAR) Safety

This device has been designed to comply with applicable safety requirements for exposure to radio waves. These requirements are designed for the safety of all persons and follow scientific guidelines, which include safety margins.

- The radio wave exposure guidelines employ a unit of measurement known as the Specific Absorption Rate or SAR. Tests for SAR are conducted using standardised methods, with the device transmitting at its highest certified power level in all used frequency bands.
- This device is designed and manufactured not to exceed the emission limits for radio frequency (RF) energy exposure.
- This device is in compliance with the Specific Absorption Rate (SAR) for general population or uncontrolled exposure limits (2.0W/kg) specified in Council Recommendation 1999/519 EC and had been tested in accordance with the measurement methods and procedures specified in EN 62209- 1:2016 and EN 62209-2:2010+AMD1:2019.
- The highest SAR value for this model tested for use when worn on the body is 1.659 W/kg (10 g) and when used at the head it is 1.625 W/kg (10g).
- This device meets RF exposure guidelines when used in the normal position at least 5 mm away from the body.

When a carry case, belt clip or holder is used for body-worn operation, it should not contain metal and should position the product at least 5 mm away from your body. Ensure the above separation distance instructions are followed.

NOTE: DOOGEE or the manufacturer is not responsible for any radio or TV interference caused by unauthorised modifications to the Product. Such modifications could void the user's authority to operate the equipment.

Data transmission is always initiated by software, which is passed down through the MAC, digital and analog baseband, and RF chip. The MAC initiates several special packets. These are the only ways the digital baseband portion will turn on the RF

transmitter, which then turns off at the end of the packet. Therefore, the transmitter will be on only while one of the aforementioned packets is transmitted. In other words, this device automatically discontinues transmission in case of either absence of information to transmit or operational failure.
